A) Applicant

1. Duly completed loan application form.
2. A copy of citizenship identity card.
3. One passport-size photograph.
4. Authenticated latest pay slip signed & sealed by the Accounts Officer.
5. For contract employees: Latest contract extension letter.
6. PF statement signed and sealed by NPPF focal person (Private Members only).

B) Guarantor (for applicants less than 2 years in service availing more than Nu. 200,000)

1. Authenticated latest pay slip signed & sealed by the Accounts Officer.
2. A copy of citizenship identity card.
3. One passport-size photograph.
4. PF statement signed and sealed by NPPF focal person (Private Members only).

****Guarantor must be an active NPPF member in the same or higher grade than the applicant who has not guaranteed more than 1 loan in any of the FIS*

**** For ESP/GSP- a regular guarantor is mandatory for a Maximum Amount of Nu. 300,000/- Only*

C) Security (Immovable property): If loan exposure in NPPF exceeds Nu. 500,000/- or more than PF accumulation.

1. Ownership Certificate of the property
2. One passport photograph and Valid CID copy of the property owner,
3. No objection form (applicable to family-owned property/joint ownership)
4. The property owner and an applicant must visit the NPPF office for execution of the mortgage deed and letter of Guarantee

D) Charges applicable

1. Loan processing fee Nu. 500/-
2. CIB fee for applicant & guarantor Nu. 300/- each
